TO WHOM IT MAY CONCERN:

WHEREAS, on February 19, 1981, EUREKA LTD., a Nevada Limited Partnership, executed as Trustor a Deed of Trust wherein FIRST CENTENNIAL TITLE CO. (iii) Contrary to the provisions of the foregoing Deed of Trust, in failing to maintain fire insurance coverage;

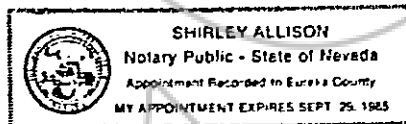
