

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Mastiff #13 Lode Mining Claim in Section 13, Township 31N, Range 50E in the Unkacua Mining District, in Eureka County, in the State of Nevada, on the 19 day of May, 1982.

The claim is 1500 feet long and 600 feet wide, and 300 feet is claimed in a NORTH direction and 1200 feet in a SOUTH direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTH to the SOUTH.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Painted with Dark Brown Paint

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a 4" DIA. Round Plastic Pipe, 5' high
- Corner No. 2 is a 4" DIA. Round Plastic Pipe, 5' high
- Corner No. 3 is a 4" DIA. Round Plastic Pipe, 5' high
- Corner No. 4 is a 4" DIA. Round Plastic Pipe, 5' high
- Corner No. 5 is a 4" DIA. Round Plastic Pipe, 5' high
- Corner No. 6 is a 4" DIA. Round Plastic Pipe, 5' high

The monumentation and marking of the corners was completed by the 7 day of JUNE, 1982.
(Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

NRS 517.300, Subsection 2.
