

CERTIFICATE of LOCATION of LODE CLAIM

TO ALL WHOM IT MAY CONCERN: ----

The undersigned hereby certify that they have located the MC #11 (Moonshine Canyon #11) Lode Mining Claim in Section 27, SE, Township 23N, Range 48E, in the Unknown Mining District, in Eureka County, in the State of Nevada, on the day of May, 19 82.

 Corner No. 5 is a 4" diameter PVC post, WSC Moonshine Canyon #11
 Corner No. 6 is a 4" diameter PVC post, NW Cor. Moonshine Canyon #11

The monumentation and marking of the corners was completed by the 13th day of May, 19 82.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
