Corner No. 6 is a 4" diameter PVC post, NW Cor. Moonshine Canyon #13

The monumentation and marking of the corners was completed by the 20th day of May, 19 82.

 have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to
