Such work or improvements and character consisted of drilling 1 hole for a total of 600 feet.

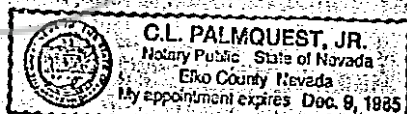
