

GRANT, BARGAIN AND SALE DEED

THIS INDENTURE is made and entered into as of this 20th day of August, 1982, by ROY L. ASH, and his wife, LILA M. ASH, collectively as "GRANTOR," in favor of, and for the benefit of, ELKO LAND AND LIVESTOCK COMPANY, a Nevada corporation, P.O. Box 979, Carlin, Nevada, 89822, as "GRANTEE;"

W I T N E S S E T H:

WHEREAS GRANTOR previously held real property interests, including interests in mineral rights appurtenant thereto, in and to a large tract of land and other scattered parcels within the counties of Elko, Eureka and Lander, State of Nevada; and

WHEREAS GRANTOR, specifically ROY L. ASH, previously conveyed away the vast majority of said real property holdings within Elko and Eureka counties, Nevada, except for the GRANTOR's interest in the mineral estate in the lands described below which is now held by the GRANTOR; and

WHEREAS it is the intention of the GRANTOR to transfer and convey all of GRANTOR's remaining interest in the mineral estate of the lands described below to the GRANTEE;

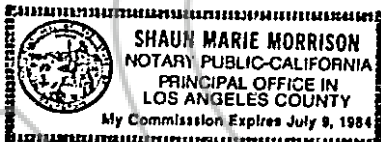

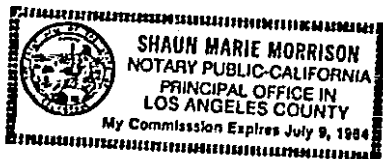
