WHEREAS, this Assignment is executed to effect the assignment to Assignee of Assignor's interest in the Agreements and all rights associated therewith;

NOW, THEREFORE, incorporating the recitals above and in consideration of the premises and other valuable consideration, receipt of which is hereby acknowledged, IT IS AGREED:

- Assignment of Agreement. Assignor, for value received, hereby transfers and assigns to Assignee all of Assignor's right, title and interest in and to the Agreements.
- 2. <u>Effective Date</u>. This Assignment shall become effective as of the date of recordation of the Deed in the official records of the County Recorder of Eureka, Elko, and Lander Counties, Nevada.
- 3. <u>Indemnification of Assignee</u>. Assignor agrees to indemnify, defend and hold the Assignee harmless from and against any claim against or liability of the Assignee arising out of the covenants and duties of Assignor under the Agreements to be performed prior to the effective date of this Assignment.
- 4. <u>Indemnification of Assignor</u>. By acceptance of this Assignment, Assignee hereby agrees to indemnify, defend and hold Assignor harmless from and against any claim against or liability of the Assignor arising out of the covenants and duties of the Assignor under the Agreements to be performed on or after the effective date of this Assignment.

- ance of this Assignment, Assignee hereby assumes and agrees to perform all of the obligations and covenants of Assignor under the terms and provisions of the Agreements to be performed on or after the effective date of this Assignment.
- Assignee each agree to execute such other documents and perform such other acts as may be necessary or desirable to effectuate the intent of this Assignment and to prorate appropriately all obligations and rights of the Assignor with respect to the Agreements as of the effective date of this Assignment.
- 7. Successors and Assigns. This Assignment shall inure to the benefit of the parties, their assigns and successors in interest or in title or in both.
- 8. Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of Nevada.
