

AMENDMENT TO OPTION TO LEASE

This amendment made this 28th day of July, 1982 between Elmer F. Schroeder and Elna Ruth Schroeder, his wife, P.O. 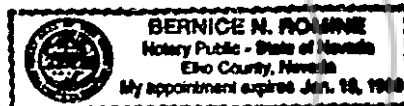
