**QUITCLAIM DEED
(WATER RIGHTS)**

THIS INDENTURE is made and entered into as of this 20th day of August, 1982 by T LAZY S RANCH, a general partnership organized under the laws of the State of California; the sole partners of which are CHARLES B. THORNTON, JR., a married man, as his sole and separate property, and WM. LANEY THORNTON, a married man, as his sole and separate property; T LAZY S FARMS, a limited partnership organized under the laws of the State of Nevada, the sole general partner of which is T LAZY S RANCH, the general partnership above described, and whose sole limited partners are CHARLES B. THORNTON, JR., a married man as his sole and separate property, and WM. LANEY THORNTON, a married man as his sole and separate property; and WM. LANEY THORNTON, a married man, as his sole and separate property, collectively as "GRANTOR;" in favor of, and for the benefit of, ELKO LAND AND LIVESTOCK COMPANY, a Nevada corporation, P.O. Box 979, Carlin, Nevada, 89822, as "GRANTEE;"

W I T N E S S E T H:

WHEREAS GRANTOR was the owner of certain real property in Eureka, Elko and Lander counties, Nevada, that simultaneously herewith have been sold and deeded to the GRANTEE; and

NOW THEREFORE, for and in consideration of TEN AND 00/100 DOLLARS (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by GRANTOR, GRANTOR intends to, and does hereby, remise, release, quitclaim and convey unto GRANTEE, forever, all of GRANTOR's right, title and interest in and to those following applications on file with the Nevada State Engineer, permits on file with the Nevada State Engineer, certificated permits on file with the Nevada State Engineer, and those rights set forth in the case entitled "In the Matter of the Determination of the Relative Rights of Claimants and Appropriators of the Waters of the Humboldt River Stream System and Tributaries, Case No. 2804 in the Sixth Judicial District Court of the State of Nevada, in and for the County of Humboldt" entered October 20, 1931, commonly referred to as the Bartlett Decree, and entered October 8, 1935, commonly referred to as the Edwards Decree, including but not limited to those portions of Proofs of Appropriations 00333, 00168, 00171, 00325, 00326, 00327, 00328 and 00329. In addition thereto, all vested rights, claims of vested rights, whether or

not on file with the Nevada State Engineer. It is the express intention of the GRANTOR and GRANTEE that all water rights of whatsoever, whether or not in good standing with the Nevada State Engineer, appurtenant to the real property described in Exhibit A attached hereto shall be signed and transferred to GRANTEE.
