6 (9) Maintaining four miles of roads & trails, drillsites;

7 (10) Reconnaissance & other field work by Gold Fields Mng
8 Corp., 55 Freeport Blvd., Sparks, NV 89431;

9 (11) Additional sampling by Bear Creek Mining on Klondike
10 Extension;

11 (12) Continued studies projecting over 90 million tons low
12 grade Pb-Zn ore, incl. 15 million tons grading over 6%, plus
13 silver. Open pit;

14 (13) Shallow percussion drilling (in progress);

15 (14) Re-monumenting;

16 (15) Laboratory rock analyses;


17 (16) Lease & repair of equipment;



18 (17) Purchase of supplies, incl. chemicals & other material;
