TITLE: REPORT ON A GEOCHEMICAL SURVEY CONDUCTED ON THE FEI PWO 1 and 2 LODE CLAIMS FOR THE 1981-82 ASSESSMENT PERIOD.

This report is in compliance with the Bureau of Land Management Circular No. 2289, "Regulations Pertaining to Mining Claims Under the General Mining Laws of 1872." (As contained in Title 43 of the Code of Federal Regulations.) Subpart 8 3851.2, Inclusion of Surveys in Assessment Work.

The Fei Pwo claims Numbers 1 and 2 are located in Section 2, T.22N, R 50 E, M D B & M, and in Section 35, T.23 N., R 50 E. M D B & M in Eureka County.

Geochemical surveys were undertaken on the ground of mineral deposits during August 1982. These surveys included the collection and preparation of geologic samples, (predominantly soil samples). (Soil Samples were collected at a depth of 4 to 6 inches.) These samples were analyzed for precious metal indicators. The preparation of these samples for analysis included drying, crushing, grinding and sifting to minus 80 mesh.

The cost of the work performed on these 2 claims amounted to more than \$200.00 dollars. The work covered the entire area of these 2 claims. Also, some of the area adjacent to these claims was included.

The basic finding of the geochemical survey have not been completed at this time. We are in the process of evaluating all of the data; chemical reports, geochemical maps, lab analyses, etc.
