16 It appearing to the satisfaction of the Court that a
17 verified Petition has been filed in the above-entitled matter,
18 and notice of the hearing thereof has been duly given as required
19 by law, the Court finds that the allegations of the Petition are
20 true and correct; that the gross value of the whole estate of
21 said decedent does not exceed the sum of \$10,000.00; that the
22 Petitioner, LAURA LEE WHITE, is one of the surviving children of
23 the decedent; that so far as is known to the Petitioner, the
24 decedent has no unpaid debts, and the expenses of last illness,
25 funeral expenses, and expenses of administration have been paid,
26 and there are no liens or encumbrances on decedent's property of
27 record at the date of her death.

28 NOW, THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED
29 that the whole of the property and estate of LAURA L. KASPAR, aka
30 LAURA LEE KASPAR, aka LAURA KASPAR, decedent, be, and the same is
31 hereby set aside to and the title thereof vested absolutely in
32 DANIEL EUGENE WHITE, MICHAEL EDWARD WHITE, and LAURA LEE WHITE,
as tenants in common, the surviving children of decedent. The

8 RESERVING THEREFROM an easement of 30 feet

10 with power to dedicate.

11 SUBJECT TO any and all exceptions,
12 reservations, restrictions, restrictive
13 covenants, assessments, easements, rights,
14 and rights of way of record.

15 TOGETHER WITH the tenements, hereditaments,
16 and appurtenances thereunto belonging or in
17 anywise appertaining, and the reversion and
18 reversions, remainder and remainders, rents,
issues, and profits thereof.
