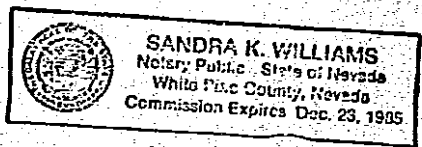

Extent of work performed: Entire claim group was mapped and 37 rock chip samples were taken.

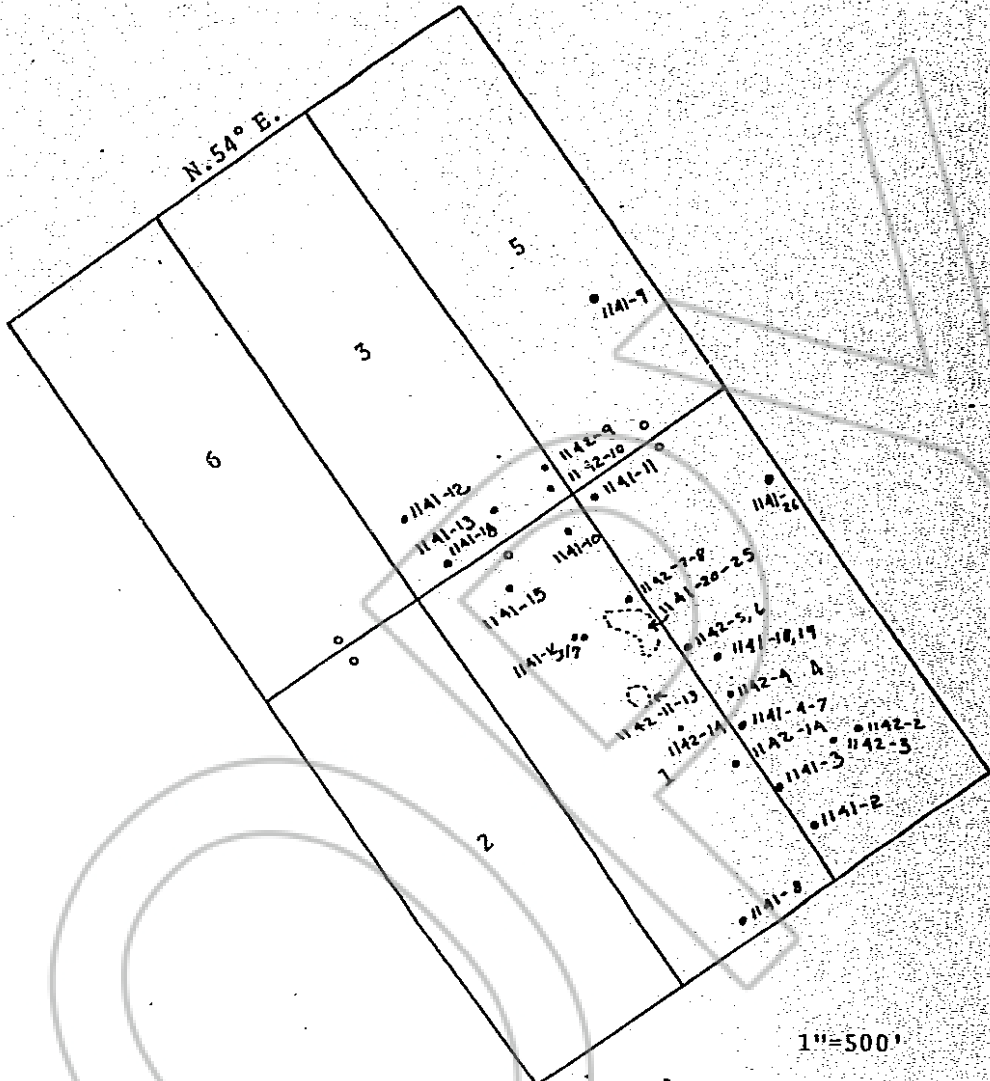
