Exploration cuts were made upon said mining claims exposing the ores thereon. The existing access road leading to said mining claims was repaired. Twentyfour mining samples were collected, prepared and assayed. Approximately 30 tons of ore were mined and stockpiled from said mining claims.

Said work was done and performed between on or about September 13, 1982 to September 25, 1982. The actual amount paid for said work was \$600.00, paid by Robert E. Brandt for the purpose of holding said claims.
