

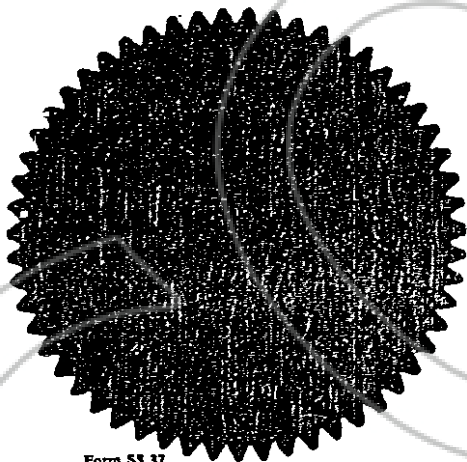

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

Whereas, WILLIE HUDSON of ELKO County, State of NEVADA according to the provisions of Chapter 321 of NRS, providing for the selection and sale of lands that have been or may hereafter be granted by the United States to the State of Nevada, has paid in full the charges and demands of the State of Nevada for the following-described lands:

The Northwest Quarter of the Southeast Quarter of Section Seventeen (17), Township Twenty(20) North, Range Fifty-two (52) East,

Mount Diablo Base and Meridian, containing Forty and 00/100 acres, according to the Official Plat of the survey on file with the United States Bureau of Land Management.

Therefore Know Ye, That the State of Nevada, in consideration of the premises, and in conformity with the Act of the Legislature in such cases made and provided, has given and granted, and by these presents does give and grant unto the said WILLIE HUDSON and to her heirs, the said tract above described, to have and to hold the same, together with all rights, privileges, immunities and appurtenances of whatever nature thereunto belonging, unto the said WILLIE HUDSON and to her heirs and assigns, forever; provided, that a right of way for ditches, tunnels, and telephone and transmission lines constructed by authority of the United States, and, also, a royalty of five (5%) percent of the net proceeds of all gas, coal, or oil mined or extracted therefrom, are hereby expressly reserved.
