Commencing at the SE Corner which bears 300 feet Southerly and 25 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 9,330 feet in a N. 37° 50' W direction from the SE Corner of Section 36, Township 27 North, Range 49 East, M.D.B.& M. This lode claim, VI No. 6, is Northerly of VI No. 6A, Southerly of VI No. 4, and Westerly of VI No. 5, lode claims.
