Said mining claim was located on August 23, 1982, in about Sections 25 and 26, Township 27 North, Range 49 East, M.D.B.& M., and is bounded and described as follows:

Commencing at the SE Corner which bears 300 feet Southerly and 25 feet Eastcommencing at the St Corner which bears 300 feet Southerly and 25 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 8,390 feet in a N. 39° 00' W. direction from the SE Corner of Section 36, Township 27 North, Range 49 East, M.D.B.& M.
