## CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS that the undersigned locators, having complied with all of the requirements of law and local rules and customs, have claimed and claim by right of discovery and location, a lode mining claim situated in an Unknown Mining District (Buckhorn), County of Eureka, State of Nevada, and hereby certify that:

Commencing at the SE Corner which bears 300 feet Southerly and 25 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning.
