Commencing at the SE Corner which bears 300 feet Southerly and 1475 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerlh 600 feet to the SW Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 6,600 feet in a N. 37° 10′ W. direction from the SE Corner of Section 36, Township 27 North, Range 49 East, H.D.B.& M.
