

**CERTIFICATE OF LOCATION
LODE MINING CLAIM**

KNOW ALL MEN BY THESE PRESENTS that the undersigned locators, having complied with all of the requirements of law and local rules and customs, have claimed and claim by right of discovery and location, a lode mining claim situated in an Unknown Mining District (Buckhorn), County of Eureka, State of Nevada, and hereby certify that:

(a) The name of said lode or vein and lode mining claim is:

(c) Said mining claim was located on September 10, 1982, in about Sections 25 and 36, Township 27 North, Range 49 East, M.D.B. & M., and is bounded and described as follows:

Commencing at the SE Corner which bears 300 feet Southerly and 1475 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 435 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 435 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 5,640 feet in a N. 35° 50' W. direction from the SE Corner of Section 36, Township 27 North, Range 49 East, M.D.B. & M. This lode claim, VI No. 15A, is Northerly of VI No. 17, Southerly of VI No. 15, and Easterly of VI No. 16A, lode claims.

(d) The undersigned claim 1500 feet linear and horizontal in measurement along the course of the vein, together with 300 feet in width on each side of the center of the vein, 25 feet of said lode running Westerly from the point of discovery (designated by the location monument). The general course of the lode as near as may be presently determined is Easterly and Westerly.

(e) Since the date of said location and prior to the date of this certificate, the undersigned caused work to be performed upon said mining claim consisting of maps as provided in NRS 517.040.

(f) The location monument, each corner and side line center marker is in each instance represented by a post at least 4 inches in diameter by 4½ feet in length and set 1 foot in the ground, the respective corner posts being marked as follows: SE Corner, VI No. 15A; SW Corner, VI No. 15 A; NW Corner, VI No. 15A; and NE Corner, VI No. 15A.
