CERTIFICATE OF LOCATION LODE MINING CLAIM

Commencing at the SE Corner which bears 300 feet Southerly and 1475 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 2855 feet in a N. 51° 35' W. direction from the SE Corner of Section 36, Township 27 North, Range 49 East, M.D.B.& M.
