APPENDIX I

EXPLORATION AGREEMENT

This Agreement, made and entered into effect the 20th day of June, 1980, by and between J. Ellerton Consultants, Inc. (hereinafter "Ellerton"), and EOR Petroleum (hereinafter "EOR").

PRELIMINARY RECITALS

WHEREAS, Ellerton is the owner of an undivided 1/15th working interest in certain leases, which total approximately 240,000 acres, all as more particularly identified on the lease schedule attached hereto as Exhibit "A" (hereinafter the "subject leases");

WHEREAS, said undivided 1/15th interest is subject to the terms and conditions of that certain draft exploration agreement made and being entered into among General American Oil Company of Texas; Pangaea Petroleum, Inc.; Depco, Inc.; and Ellerton, a copy of which is attached hereto, identified as Exhibit "B" (hereinafter the "General American Agreement");

WHEREAS, Ellerton and EOR have reached an Agreement whereby EOR shall participate in the expenses and share in the revenues attributable to Ellerton's participation in the General American Agreement;

CONSIDERATION

NOW THEREFORE, in consideration of the premises, the mutual covenants herein contained, and other good and valuable consideration, receipt of which is acknowledged by the parties, it is agreed as follows:

TERMS OF AGREEMENT

I. Definitions

Terms used in this Agreement shall be defined as in the General American Agreement with the following exceptions:

1. Party or parties - the term "party" or "parties" when used herein shall refer only to Ellerton and/or EOR, and shall not include any persons or entities named in the General American Agreement except as specifically provided herein.

II. Governmental Regulation

All the terms and provisions of this Agreement are expressly made subject to the terms and provisions of all federal and state laws and to all orders, rules, and regulations of any duly constituted authority having jurisdiction, and shall be automatically supplemented and/or amended accordingly. The parties agree to comply with all such laws, orders, rules, and regulations.

III. Description of Exploration Program

The terms and conditions of the General American Agreement, as the same may finally be entered into, describing the rights and responsibilities of the parties to that Agreement shall upon approval by EOR, be binding upon the parties to this agreement, and said terms and conditions are hereby incorporated by reference as if the same were fully set forth herein.

In the event EOR fails to approve the General American Agreement ^{within two weeks of receipt of said Agreement}, this Agreement is null and void and Ellerton may retain, as liquidated damages, all payments made pursuant to Section IV, Item 2, set forth below.

IV. Payment of Costs

1. In consideration of its right to share in the revenue derived from the operations described in the preceding section, EOR agrees to pay Ellerton the total sum of \$168,750.00. Said amount shall be paid as follows:

- (a) \$20,000.00 - upon execution of the Agreement
- (b) \$48,750.00 - October 1, 1980
- (c) \$100,000.00 - January 1, 1981

2. In addition to the payments previously described, EOR shall pay 100% of Ellerton's costs associated with the operations described in Part III above until commencement of the first exploratory well under said program. Associated costs may include payments for lease rentals, geophysical evaluation, geological investigation, consultants' fees, and other payments associated with evaluation of the subject

leases and preparation for commencement of the first exploratory well. The enumeration of specific items of cost is for purposes of illustration only, and is not in any way intended to limit the generality hereof.

3. EOR further agrees to pay 100% of Ellerton's costs associated with the drilling to casing point³ of the first two wells in that program set out in the description of operations in Section III above. *RLV*

4. Costs associated with the described project other than those described in Paragraphs 2 and 3 above will be shared by the parties hereto in the following proportions:

- (a) EOR - 75%
- (b) Ellerton - 25%

5. The division of costs described in Paragraph 2, 3 and 4 above shall apply on a pro-rata basis to the subject leases and to any new lands acquired during the term of the described operations. All said costs shall be paid by EOR within thirty (30) days after the same are charged to it by Ellerton.

6. Subject to the terms and conditions set forth in Section III herein; in the event EOR shall fail to make the payments due as described in Paragraph 1, Ellerton shall have the right to consider EOR's right to and interest in the project forfeited. In the event of such forfeiture, all funds paid to the date of such forfeiture shall be retained by Ellerton as liquidated damages for EOR's failure to make the payments due.

7. In the event of failure of EOR to pay any costs described in Paragraphs 2 and 3 above ~~coming due on or after~~ *RLV* *AC* ~~January 2, 1984~~, EOR shall be subject to those penalties described in the General American Agreement.

8. In addition to the payments previously described, the parties hereto recognize that Ellerton will provide con-

sulting and other services on the project. The parties agree that, in consideration for said provision of services, EOR shall pay Ellerton for his time spent in operating said projects beginning January 1, 1981. Ellerton's charges for said time shall be computed on a basis of \$300 per day. EOR shall pay these charges within thirty (30) days after presentation of them by Ellerton.

V. Sharing of Revenues

In consideration of EOR's payment of the costs described above, EOR shall receive 75% of the revenue received by Ellerton from the described operation once obligations are met. Said right to receive revenue shall be subject to any penalties in effect as described in Section IV, Part 7 above.

VI. Meetings

EOR shall be entitled to designate one representative of EOR to attend meetings as described in the General American Agreement called for the purpose of approving prospects, lease acquisitions, recommendations, economic and geologic evaluations of exploratory prospects, or any other matters relevant to the General American Agreement which the parties to said Agreement may agree to discuss. Upon designation by EOR of said representative, Ellerton shall in writing supply the name, address, and telephone number of the individual designated to all parties to the General American Agreement designating that person as one of Ellerton's representatives pursuant to Section ~~VIII~~ ^{contained in General American} of said Agreement.

VII. Miscellaneous

1. Modification of the terms and conditions of this Agreement shall be made only in writing signed by both parties.
2. Time shall be of the essence hereof.

3. In the event of disagreement between EOR and Ellerton with regard to the management of the venture, EOR, due to its 75% interest in the Ellerton/EOR Exploration joint venture, shall have the exclusive authority to make final management decisions, *after January 2nd 1981, binding only on its own 75% interest.*

4. This Agreement shall be binding on the parties hereto, their heirs, representatives, successors, and assigns. Nothing herein contained restrict assignment hereby by EOR, so long as any Assignee is financially able to perform the obligation of EOR hereunder.

5. It is further agreed by the parties that the Joint Venture formed hereunder and will not file U. S. partnership returns, but rather that each party shall be responsible for filing its own U. S. tax return.

6. It is further agreed that this Agreement shall be construed under the laws of the State of Colorado.
