AMENDED  
ORDER SETTING ASIDE ESTATE  
WITHOUT ADMINISTRATION

IT APPEARING to the satisfaction of the Court that a  
verified petition has been filed and notice of hearing thereon  
has been duly given as required by law and that the net value of  
the whole estate of said decedent does not exceed the sum of TEN  
THOUSAND DOLLARS (\$10,000.00) over and above all liens or encum-  
brances of record at the date of death of said CARRIE E. McKAY,  
deceased, and that all debts of decedent, including expenses of  
last illness, funeral and expenses of administration have been  
fully paid.

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED by the  
Court that the whole of the estate of the said CARRIE E. McKAY,  
deceased, be and the same is hereby assigned to, and that the  
title thereof shall vest absolutely in: ROBERT N. McKAY, WILLIAM  
M. McKAY, RICHARD W. McKAY, and MARJORIE M. HAMMOND, the surviving  
children of said decedent, subject to whatever mortgages, liens

1 or encumbrances of record there may have been thereon at the time  
2 of the death of said decedent.

3 The said property consists of the following described  
4 real property situate in the Town of Eureka, County of Eureka,  
5 State of Nevada, and more particularly described as follows,  
6 to-wit:

7 Lots 3, 4, 5, 6 in Block 93 of the town  
8 of Eureka, Nevada, together with all im-  
9 provements situate thereon.

10 A one-fifth (1/5) interest of a one-half  
11 (1/2) interest of Lots 19, 20, 21, 22, 23,  
12 24, 25, 26, 27, 28, 29 in Block 16 of the  
13 town of Eureka, Nevada.


14 A one-fifth (1/5) interest of a one-half

31 the north end line of Block 4 to the place  
32 of beginning.
