16 TO SET ASIDE ESTATE WITHOUT ADMINISTRATION

17 COMES NOW, the Petitioner, HELEN E. HALSTEAD, and
18 presents the Last Will and Testament of said decedent and proves
19 to the satisfaction of the Court that the time for hearing the
20 petition for the probate of the Will was by the Clerk duly set
21 for hearing on the 26th day of March 1982, and that notice of
22 said hearing has been given, and no person appearing to contest
23 the said petition, the Court proceeds to hear the evidence and
24 thereupon finds the facts alleged therein to be true, and that
25 said petition ought to be granted, and it appearing that the
26 total value of the estate of said decedent over and above all
27 liens or encumbrances of record at the date of death of decedent
28 does not exceed \$10,000.00, that the same be set aside to the
29 heirs of said decedent in accordance with the Last Will and
30 Testament of JOHN JOSEPH FRANCIS GIBELLINI, deceased, that all
31 expenses of last illness and funeral, together with all debts
32 . . .

1 of decedent have been fully paid, including expenses of admini-
2 stration.

3 IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED by the
4 Court that the whole of the estate of said JOHN JOSEPH FRANCIS
5 GIBELLINI, deceased, be and the same is hereby distributed to
6 HELEN E. HALSTEAD and SHIRLEY J. SMITH strictly in accordance
