# CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-  
signed, does hereby locate the CC 22 Lode Mining Claim on this

District, Eureka County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 34  
Township 23 North, Range 50 East, Mt. Diablo P.M., and more particularly

Beginning at the northeast corner post No. 1,

Thence, 600 feet in a Southerly direction to Post No. 2,
