

DEED OF TRUST

KNOW ALL MEN BY THESE PRESENTS: That PLACER AMEX, INC., a California corporation; SOHIO PETROLEUM COMPANY, a Delaware corporation (successor in interest to WEBB RESOURCES, INC., a Colorado corporation); and VERNON F. TAYLOR, JR., of Denver, Colorado, hereinafter called the Trustors, whose address is Suite 2500, 1 California Street, San Francisco, California 94111-5472, do hereby irrevocably grant, transfer and assign to TITLE INSURANCE AND TRUST COMPANY, a California corporation, hereinafter called Trustee, for the benefit of THE BUNKER HILL COMPANY, a Delaware Corporation, P. O. Box 29, Kellogg, Idaho 83837, hereinafter called the Beneficiary, the property described on Exhibit A, pages 1 through 25, attached hereto and made a part hereof as though fully set forth herein, including any interest therein which the Trustors may hereafter acquire, together with all the tenements, hereditaments, and appurtenances now or hereafter thereunto belonging or in anywise appertaining, and all rents, issues and profits thereof (provided, however, that the Trustors shall be entitled to collect and retain the said rents, issues and profits until default hereunder), and all fixtures now or hereafter attached to or used in connection with the premises herein described.

This grant is intended as a Deed of Trust to secure payment of that certain promissory note of even date herewith, and any extension or renewal thereof, in the principal sum of \$2,400,000 executed and delivered by the Trustors to the Beneficiary, of which the following is a copy:

FOR VALUE RECEIVED, PLACER AMEX, INC., a California corporation, SOHIO PETROLEUM COMPANY, a Delaware corporation, and VERNON F. TAYLOR, JR., of Denver, Colorado, (hereafter collectively "the makers"), hereby promise to pay to THE BUNKER HILL COMPANY or order the principal sum of TWO MILLION FOUR HUNDRED THOUSAND DOLLARS (\$2,400,000) together with interest on the unpaid principal balance hereof from the date of this Note at the rate of eight and one-half percent (8.5%) per annum (all interest payments due on this Note to be computed for the actual number of days elapsed on the basis of a 360-day year) as follows: on October 31, 1983 and October 31, 1984, there shall be payable equal

principal payments of \$800,000 together with interest on the outstanding principal amount of this note at the rate stated herein, and on October 31, 1985, there shall be payable a final principal payment of \$800,000 together with interest thereon at the rate stated above.

Payments of principal and interest shall be made at the office of The Bunker Hill Company, Kellogg, Idaho, in such coin or currency of the United States of America as at the time of payment is legal tender for the payment of public and private debts.

This Note is subject to prepayment, in whole or in part, at any time without premium plus accrued interest to the date of prepayment.

This Note is an unregistered Note and is transferable by endorsement and delivery.

This note is secured by a Deed of Trust, dated December 3, 1982 (the "Deed of Trust"), from the makers to THE BUNKER HILL COMPANY, a Delaware corporation, covering certain property located in Eureka and Lander Counties, Nevada, described therein.

The principal of this Note may be declared forthwith due and payable, without presentment, demand, protest or other notice of any kind, all of which are expressly waived by the makers under the following circumstances: (i) a default by the makers under any provision of the Deed of Trust or (ii) an order for relief is entered under the United States bankruptcy laws or any other decree or order is entered by any federal or state court having jurisdiction in the premises (A) adjudging the makers bankrupt or insolvent, or (B) approving as properly filed a petition seeking reorganization, arrangement, adjustment or composition of or in respect of the makers under the United States bankruptcy laws or any other applicable federal or state law, or (C) appointing a receiver, liquidator, assignee, trustee, custodian, sequestrator (or other similar official) of the makers or of any substantial part of the property or assets of the makers or (D) ordering the winding up or liquidation of the affairs of the makers and any such decree or order continues unstayed and in effect for a period of 60 consecutive days or (iii) in the event of a dissolution of the makers, or (iv) the

failure of the makers to make any principal or interest payment when due under this Promissory Note.

This Note is governed by, and construed in accordance with, the laws of the State of Nevada.

The parties hereby covenant and agree as follows:

1. Trustors will pay the indebtedness, as hereinbefore provided.
2. Trustors will pay all taxes and assessments of every kind, nature and description, levied or assessed against the real property described subsequent to the date of this Deed of Trust, promptly when due.
3. Trustors will promptly discharge any liens, judgments or encumbrances placed upon the property described subsequent to the date of this Deed of Trust.
4. Beneficiary may perform any defaulted covenant or agreement of Trustors contained herein to such extent as Beneficiary shall determine, and any moneys advanced by Beneficiary for such purposes shall bear interest at eight and one-half percent (8.5%) per annum, shall thereupon become a part of the indebtedness secured by this instrument, ratably and on a parity with all other indebtedness secured thereby, and shall be payable upon demand.
5. Trustors will continuously maintain hazard insurance, of such type or types and amounts as Trustors maintained as of November 29, 1982, on the improvements now or hereafter placed on said premises, and they will pay promptly when due any premiums therefor. All insurance shall be carried in companies authorized to do business in Nevada and the policies and renewals thereof shall have attached thereto loss payable clauses in favor of and in form acceptable to the Beneficiary. In event of loss, Trustors will give immediate notice by mail to the

Beneficiary who may make proof of loss if not made promptly by the Trustors. The insurance proceeds, or any part thereof, may be applied by the Beneficiary at its option, either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged.

6. Trustors shall not commit or permit waste; and shall maintain the property in as good condition as at present, reasonable wear and tear excepted. Upon any failure to so maintain, Beneficiary, at its option, may cause reasonable maintenance work to be performed at the cost of Trustors.

7. In the event of default, Beneficiary shall have the right, at its option, to take immediate possession of the described property for the purpose of protecting it from deterioration or decrease in value, and to conduct operations upon the property pending sale. All costs and expenses incurred in protecting the property described herein after default, and pending sale, shall be accurately accounted for and charged to Trustors, and added to the indebtedness due and owing at the time of default together with interest on said sum at the rate of eight and one-half percent (8.5%) per annum, and said sums shall be secured ratably with the other indebtedness secured hereby.

8. In the event of default, Beneficiary shall have the right of full and complete access, without charge, to the property described herein, for the purpose of mining, developing and exploring any and all property which is the subject of this Deed of Trust, including the right to build roads for such purpose, to sink shafts, to use appropriate mining methods, to use existing ventilation and manways and the full right of ingress and egress.

9. The lien of this instrument shall remain in full force and effect during any postponement or extension of the time of payment of the indebtedness or any part thereof secured hereby.

10. The Beneficiary's failure to enforce its rights upon breach or default of any of the terms hereof shall not thereby waive its rights in case of any subsequent breach or default.

11. That upon written request of Beneficiary stating that all sums secured hereby have been paid, and upon surrender of this Deed and said note to Trustee for cancel-

lation and retention and upon payment of its fees, Trustee shall reconvey, without warranty, the property then held hereunder. The recitals in such reconveyance of any matters or facts shall be conclusive proof of the truthfulness thereof. The grantee in such reconveyance may be described as "the person or persons legally entitled thereto." Five years after issuance of such full reconveyance, Trustee may destroy said note and this Deed (unless directed in such request to retain them).

12. That upon default by Trustors in payment of any indebtedness secured hereby or in performance of any agreement hereunder, Beneficiary may declare all sums secured hereby immediately due and payable by delivery to Trustee of written declaration of default and demand for sale and of written notice of default and of election to cause to be sold said property, which notice Trustee shall cause to be filed for record. Beneficiary also shall deposit with Trustee of this Deed, said note and all documents evidencing expenditures secured hereby.

After the lapse of such time as may then be required by law following the recordation of said notice of default, and notice of sale having been given as then required by law, Trustee, without demand on Trustors, shall sell said property at the time and place fixed by it in said notice of sale, either as a whole or in separate parcels, and in such order as it may be determined, at public auction to the highest bidder for cash in lawful money of the United States, payable at time of sale. Trustee may postpone sale of all or any portion of said property by public announcement at such time and place of sale, and from time to time thereafter may postpone such sale by public announcement at the time fixed by the preceding postponement. Trustee shall deliver to such purchaser its deed conveying the property so sold, but without any covenant or warranty, express or implied. The recitals in such deed of any matters or facts shall be conclusive proof of the truthfulness thereof. Any person, including Trustors, Trustee, or Beneficiary, may purchase at such sale.

After deducting all costs, fees and expenses of Trustee and of this Trust, including cost of evidence of title in connection with sale, Trustee shall apply the proceeds of sale to payment of: all sums expended under the terms hereof, not then repaid, with accrued interest at the amount allowed by law in effect at the date hereof; all other sums

then secured hereby; and the remainder, if any, to the person or persons legally entitled thereto.

13. Beneficiary, or any successor in ownership of any indebtedness secured hereby, may from time to time, by instrument in writing, substitute a successor or successors to any Trustee named herein or acting hereunder, which instrument, executed by the Beneficiary and duly acknowledged and recorded in the office of the recorder of the county or counties where said property is situated, shall be conclusive proof of proper substitution of such successor Trustee or Trustees, who shall, without conveyance from the Trustee predecessor, succeed to all its title, estate, rights, powers and duties. Said instrument must contain the name of the original Trustors, Trustee and Beneficiary hereunder, the document number or the book and page where this Deed is recorded and the name and address of the new Trustee.

The covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective successors and assigns of the parties hereto. Whenever used, the singular number shall include the plural, the plural the singular, and the term "beneficiaries" shall include any payee of the indebtedness hereby secured or any transferee thereof whether by operation of law or otherwise.




