

## MINING DEED

This MINING DEED, dated this 22nd day of December, 1982, between Occidental Minerals Corporation, a Delaware corporation ("Grantor"), the address of which is Irongate Building 4, 777 South Wadsworth Boulevard, Lakewood, Colorado 80226, a wholly-owned subsidiary of Occidental Petroleum Corporation, and Phelps Dodge Corporation, a New York corporation ("Grantee"), the address of which is 300 Park Avenue, New York, New York 10022.

## WITNESSETH:

For and in consideration of the sum of Ten Dollars (\$10.00) cash in hand paid by Grantee to Grantor and for other good and valuable consideration, the adequacy and receipt of which are hereby acknowledged by Grantor, Grantor does hereby assign and quitclaim unto Grantee, its successors and assigns, all of Grantor's right, title and interest in and to the unpatented lode and unpatented placer mining claims described in Exhibit A attached hereto and made a part hereof (hereinafter referred to as the "Mining Claims") (together with all of the veins, lodes, ledges, metals, ores, minerals, earth, and rock contained therein, and all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, including without limitation all extralateral rights, water rights, easements, and right of ways), and any and all of the lands covered by the Mining Claims, which Grantor now owns or within fifteen (15) years hereafter acquires.
