5 1. That Plaintiff is entitled to Default Judgment  
6 against the Defendant, Crescent Valley Resources Company, a  
7 Nevada Corporation, and that Defendant is indebted to the  
8 Plaintiff in the sum of One Thousand Seven Hundred Twenty  
9 Three and 03/100ths Dollars (\$1,723.03) for office space and

12 pay.

13 2. That Plaintiff is entitled to a reasonable
