

NOTICE OF LIEN

COMES NOW, D.G. REITH, PRESIDENT OF RANGER INC., and files the following Notice of Lien pursuant to Title 9, Chapter 108 of the Nevada Revised Statutes.

1. The lien claimant is RANGER INC., P.O. Box 415, Eureka, Nevada 89316. The lien claimant is engaged in the business of geologic exploration work for mining exploration and development.

2. The demand of the lien claimant is the sum of \$2,162.15 less the sum of \$1,225.00 previously paid, leaving a balance of \$937.15.

3. The owner or reputed owner of the property upon which the lien attaches is: RICHARD K. MULVANEY, P.O. Box 23, Crescent Valley, Nevada 89821; WALTER W. SMITH, 5611 Highland Drive, Salt Lake City, Utah 84121.

4. The name of the person with whom the lien claimant dealt on behalf of the owner of the property is: MERL NELSON, WALT SMITH and JIM WILKING.

5. The agreement between the lien claimant and Sunny Hill Mines Inc. and the Bagley Corporation was for the lien claimant to furnish certain geological exploration work on the Red Hill claims. In return, Sunny Hill Mines Inc. and the Bagley Corporation was to pay the claimant \$300.00 per day plus travel and out-of-pocket expenses. The claimant actually furnished 1 travel day @ \$100.00, 3 days @ \$300.00, and 2 one-half (1) days @ \$300.00 per day, mileage expense of \$405.85, office time of 5.5 hours @ \$35.00 per hour, assays and shipping samples of \$263.80, for which he has billed Sunny Hill Mines Inc.

6. The property to be charged with the lien is as follows: Sections 7, 8, 17, 18, Township 26 North, Range 53 East, MDB&M - the Red Hill 1 thru 31 claims.

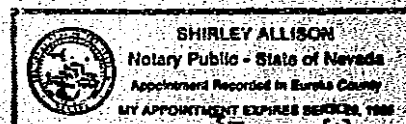
