MEMORANDUM OF LEASE AND OPTION TO PURCHASE AGREEMENT

THIS MEMORANDUM, dated as of the 23 day of December, 1982, discloses of record that for the term and on the terms and conditions of that certain Lease and Option to Purchase Agreement of even date hereto whereby THOMAS R. 
