
1 previously having withdrawn, and after hearing the attorneys
2 for the moving parties in support of said motions and upon the
3 evidence adduced at the hearing, and due deliberation having
4 been had, and upon the findings that the allegations in the
5 motions are true and that cause exists for the appointment of
6 a Trustee herein, it is

7 ORDERED, that DOUGLAS C. FLETCHER, a disinterested person,
8 be and he is hereby appointed Trustee of the property of the
9 Debtor, and it is further

10 ORDERED that said Trustee qualify before five days after
11 the date hereof and before beginning official duties by filing
12 with the Court a bond in the sum of \$75,000.00., in favor of
13 the United States, conditioned upon the faithful performance
14 of such official duties, and it is further

15 ORDERED, that upon qualification as aforesaid, the Trustee
16 shall operate the Debtor's businesses unless otherwise ordered
17 and shall consummate the pending sales of debtor's real property
18 and personal property as ordered by this Court.
