1. Those rights for water pipeline purposes which have been granted to T Lazy S Ranch, its successors or assigns, by permit No. N-12848, under the Act of October 21, 1976, 90 Stat. 2776, 43 U.S.C. 1761.
2. Those rights for power line purposes which have been granted to Sierra Pacific Power Company, its successors or assigns, by permit No. N-13257, under the Act of October 21, 1976, 90 Stat. 2776, 43 U.S.C. 1761.
3. A reservation of all mineral rights to a previous owner.
