NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 4 Mill Site on this 31st day of JANUARY, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.

The name of the vein or lode claim or mine of which Exxon Corporation is the proprietor is the following: LODE MINING claim name M.H. claim no. 52 located in Section 27, Township 23N, Range 51E, in Eureka County, Nevada

To tie this Mill Site to an official corner of the United States public land survey, begin at the SW corner of Section 30, Township 23N, Range 52E, Mt. Diablo P.M., bear South 10,800 feet, and East 6000 feet, to the northeast corner of this Mill Site.
