NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 10 Mill Site on this 30<sup>th</sup> day of JANUARY, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.

The name of the vein or lode claim or mine of which Exxon Corporation is the proprietor is the following: LODE MINING claim name M.H., claim no. 58 located in Section 34, Township 23 N., Range 51 E. in Eureka County, Nevada

The number of feet or acres claimed in this Mill Site is 4.96 acres
