NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 152 Mill Site on this 2nd day of February, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.

To tie this Mill Site to an official corner of the United States public land survey, begin at the SW corner of Section 30, Township 23N, Range 52E, Mt. Diablo P.M., bear South 16,800 feet, and East 11,400 feet, to the northeast corner of this Mill Site.
