NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 222 Mill Site on this 10<sup>th</sup> day of February, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.
