NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

The monument on which this notice of location is posted is at a point along the north boundary of the Mill Site approximately 0 feet from the East side and 360 feet from the West side of the Mill Site.

To tie this Mill Site to an official corner of the United States public land survey, begin at the SW corner of Section 30, Township 23N, Range 52E, Mt. Diablo P.M., bear South 21.600 feet, and East 18.240 feet, to the northeast corner of this Mill Site.
