NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

To tie this Mill Site to an official corner of the United States public land survey, begin at the SW corner of Section 30, Township 23N, Range 52E, Mt. Diablo P.M., bear South 23400 feet, and East 9240 feet, to the northeast corner of this Mill Site.
