# NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 609 Mill Site on this 5th day of February, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.
