NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 719 Mill Site on this 6th day of February, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.

The name of the vein or lode claim or mine of which Exxon Corporation is the proprietor is the following: LODE MINING claim name M.H., claim no. 1075 located in Section 26, Township 22N, Range 51E in Eureka County, Nevada.

To tie this Mill Site to an official corner of the United States public land survey, begin at the SW corner of Section 30, Township 23N, Range 52E, Mt. Diablo P.M., bear South 25200 feet, and West 1920 feet, to the northeast corner of this Mill Site.
