## NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 798 Mill Site on this 15 day of February, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.

The point of beginning and all posts referred to above measure 4 inches by 4 inches by 5 feet.

The monument on which this notice of location is posted is at a point along the north boundary of the Mill Site approximately 0 feet from the East side and 360 feet from the West side of the Mill Site.

To tie this Mill Site to an official corner of the United States public land survey, begin at the SW corner of Section 30, Township 23N, Range 52E, Mt. Diablo P.M., bear South 26.400 feet, and East 49.20 feet, to the northeast corner of this Mill Site.
