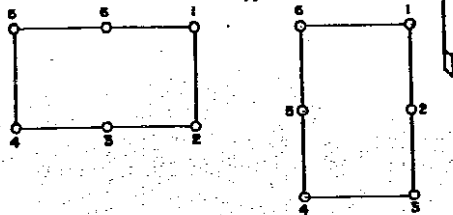


Diagram showing method of describing mill site:

### NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 914 Mill Site on this 31st day of January, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.

The name of the vein or lode claim or mine of which Exxon Corporation is the proprietor is the following: LODE MINING claim name M.H., claim no. 952 located in Section 1011, Township 22N, Range 52E, in Eureka County, Nevada

The number of feet or acres claimed in this Mill Site is 4.96 acres

This Mill Site is located in the NW (Quarter) of Section(s) 30, Township 22N, Range 52E, Mt. Diablo P.M., in the Mt. Hope Mining District, Eureka, County, Nevada, and is described as follows:

With reference to the diagram(s) shown above, beginning at the northeast corner post No. 1,

thence approximately 300 feet in a Southerly direction to Post No. 2,  
thence approximately 300 feet in a Southerly direction to Post No. 3,  
thence approximately 360 feet in a Westerly direction to Post No. 4,  
thence approximately 300 feet in a Northerly direction to Post No. 5,  
thence approximately 300 feet in a Northerly direction to Post No. 6,  
thence approximately 360 feet in a Easterly direction to Post No. 1,

The point of beginning and all posts referred to above measure 4 inches by 4 inches by 5 feet.

The monument on which this notice of location is posted is at a point along the north boundary of the Mill Site approximately 0 feet from the East side and 360 feet from the West side of the Mill Site.

To tie this Mill Site to an official corner of the United States public land survey, begin at the SW corner of Section 30, Township 23N, Range 52E, Mt. Diablo P.M., bear South \_\_\_\_\_, 2100 feet, and East 5230 feet, to the northeast corner of this Mill Site.

Dated and certified this 3 day of February, 1983, and filed in duplicate, along with two copies of a map of the Mill Site not exceeding 3 feet by 4 feet, with the County Recorder of the County in which the Mill Site is located.
