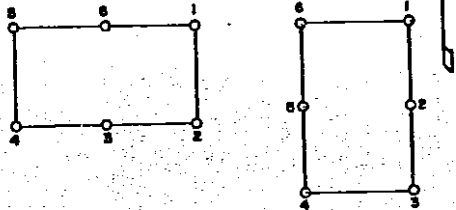

NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the MT 815 Mill Site on this 3rd day of February, 1983, in accordance with the mining laws of the United States of America and of the State of Nevada.

 thence approximately 300 feet in a Northerly direction to Post No. 5,
 thence approximately 300 feet in a Northerly direction to Post No. 6,
 thence approximately 360 feet in a Easterly direction to Post No. 1,

The point of beginning and all posts referred to above measure 4 inches by 4 inches by 5 feet.

The monument on which this notice of location is posted is at a point along the north boundary of the Mill Site approximately 0 feet from the East side and 360 feet from the West side of the Mill Site.
