REVOCATION
OF
POWER OF ATTORNEY

WHEREAS, by Power of Attorney dated May 1, 1978, Marathon Petroleum Company, (formerly Marathon Oil Company), an Ohio corporation, authorized and granted certain powers to Robert H. Steed, as its Casper Division Exploration Manager, to be used in connection for the following purposes:

To execute and accept for and on behalf of Marathon Petroleum Company, as lessee, oil and gas leases taken in the name of the Company or assigned to it, and amendments and ratifications of leases; assign oil and gas leases and to release and cancel the same; execute on behalf of this Company unit agreements, division orders, farmout agreements, and right of way agreements; accept on behalf of this Company change of depositories and subordination agreements limited to subordinating others' interests to that of this Company; and execute for and on behalf of this Company instruments, contracts, and agreements relative to drilling, operation and development of the Company's properties.

WHEREAS, Powers of Attorney have been granted to Robert H. Steed, but expressly limited to instruments affecting or pertaining to properties located within the following States: Idaho, Nevada, Utah, Arizona, Montana, Wyoming, Colorado, New Mexico, North Dakota, South Dakota, Nebraska, Kansas, Washington, Oregon and California.

WHEREAS, Robert H. Steed, Attorney-in-Fact for MARATHON PETROLEUM COMPANY, (formerly Marathon Oil Company), is no longer serving said corporation in the capacity above stated.

NOW, THEREFORE, in accordance with the final paragraph of the Power of Attorney now on file in certain counties of said States, said Power of Attorney is revoked as of
September 27 , 1982.
