

## LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

THAT MARATHON OIL COMPANY, a corporation duly organized and existing under and by virtue of the laws of the State of Ohio, having its principal office in the City of Findlay, Hancock County, Ohio, has made, constituted, and appointed and does hereby make, constitute and appoint Robert H. Steed, its Casper Division Exploration Manager, as its true and lawful attorney for the limited purposes set forth below, giving and granting unto its said attorney full power and authority, to execute for it and in its name, place and stead:

- (a) Oil and gas leases taken in the name of the Company, as Lessee, or assigned to it, and amendments and ratifications of such leases;
- (b) Assignments, releases and cancellations thereof;
- (c) Unit agreements, division orders, farm-out agreements, and right-of-way agreements;
- (d) Change of depositories and subordination agreements limited to subordinating others' interests to that of the Company; and,
- (e) Instruments, contracts, and agreements relating to drilling, operation and development of the Company's properties;

This power of attorney shall continue and remain in full force and effect until revoked by instrument duly executed and recorded.
