

ASSIGNMENT

FOR VALUABLE CONSIDERATION, the undersigned, LAVERNE D. MACHACEK and EUNICE M. MACHACEK, husband and wife, ("MACHACEK"), hereby grant, assign and transfer to the Nevada Livestock Production Credit Association ("PCA") all payments and proceeds hereinafter set forth, payable to MACHACEK by JACK C. BALISTRERI and KATHRYN A. BALISTRERI, husband and wife, ("BALISTRERI"), pursuant to that certain Contract of Sale dated the 1st day of April, 1983, by and between MACHACEK as Seller and BALISTRERI as Buyer, in accordance with Paragraphs 2(A), (B) and (C) thereof, entitled Purchase Price, Seller's Equity.

The sums assigned and time of payment are as follows:

\$20,169.08 on or before August 1, 1984;
\$20,169.08 on or before October 1, 1984;
\$20,169.08 on or before December 1, 1984;

\$20,169.08 on or before the 1st day of August, October and December of each year thereafter for a period not to exceed seven (7) years, until MACHACEK's obligations and indebtedness with PCA is satisfied in full.

PCA may refund to MACHACEK such sums received in any year subsequent to the fifth year, 1988, beginning in 1989, which are in excess of MACHACEK's annual debt to PCA, which total debt shall be paid over seven (7) years or less, and in no event longer than seven (7) years from December 1, 1984, as determined in PCA's sole discretion and so long as MACHACEK is not in default with PCA in any manner or respect whatsoever pursuant to MACHACEK's loan obligations and security agreements with PCA.

However, it is specifically acknowledged, understood and agreed by MACHACEK that in the event BALISTRERI should prepay all or any portion of BALISTRERI's payments due to MACHACEK under said Contract, that all such payments shall be paid directly to PCA and applied by PCA to MACHACEK's loan obligations with PCA, unless PCA shall otherwise decide to disburse all or a portion of said prepayments or additional payments to MACHACEK.

This Assignment shall remain in effect until the total indebtedness of MACHACEK to PCA has been paid in full and written notice thereof has been given to BALISTRERI by PCA. MACHACEK hereby authorizes and directs payment by BALISTRERI, their agents and representatives, to PCA or its successors and assigns, of the sums so payable to MACHACEK as hereinabove set forth.

The terms and conditions of any and all security agreements and/or other loan and security documents executed by MACHACEK in favor of PCA are hereby made a part hereof and incorporated herein by reference to the same extent and effect as if set forth in full herein.

PCA shall have all rights and remedies to enforce this Assignment and payments to be made hereunder pursuant to any such security agreements and loan obligations of MACHACEK and such other rights and remedies at law and in equity as PCA may have resulting from any default of MACHACEK and/or BALISTRERI relating to this Assignment.

MACHACEK shall execute and deliver to PCA at any time and from time to time such further instruments, documents, agreements and assurances as may be reasonably requested by PCA to properly effectuate the intent of any provision manifested herein.

This Assignment shall inure to the benefit of PCA, its successors and assigns, and shall be binding upon MACHACEK, their heirs, executors, administrators, successors and assigns.

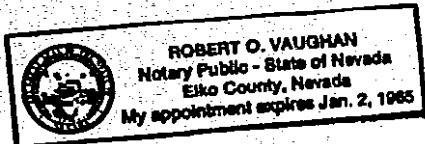

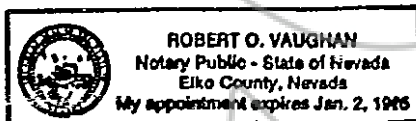
