The claim is 1320 feet long and 120 feet wide, and 1220 feet is claimed in a NORTHERLY direction and 100 feet in a SOUTHERLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 60 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTH to the SOUTH.
