AMENDED CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED HEREBY certifies, that EXXON CORPORATION, through its Employee and Representative, the undersigned, does hereby make and file this 1st Amended Location of the MT 453 Lode Mining Claim, on this 5th day of May, 1983, and situated in the Mt. Hope Mining District, Eureka County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 13, Township 22N, Range 51E, Mt. Diablo P.M. and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1:
