The claim is 1500 feet long and 600 feet wide, and 200 feet is claimed in an EASTERNLY direction and 1300 feet in a WESTERNLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTHEAST to the SOUTHWEST.
