

# Certificate of Location of Lode Mining Claim

The undersigned hereby certifies that he has located the WP No. 59  
Lode Mining Claim in the  
NW, NE Quarter, Section 18, Township 34 N, Range 51 E, M.D.B. & M.,  
in Eureka County, Nevada, on the 25 day of June, 1983.

The claim is 1500 feet long and 250 feet wide, and 1480 feet is claimed  
in a East direction and 20 feet in a West direction from the  
location monument, at which the Notice of Location is posted, lengthwise of the  
claim, together with 125 feet in width on each side of the center of the claim.  
The general course of the lode deposit and premises is from the East to  
the West.

The location and number of each corner of this claim is shown on the claim  
map that is filed herewith. On the ground, each corner of the claim is marked with  
its appropriate number by marking the claim name and number on an aluminum tag.

The description of each corner is as follows:

Northwest Corner No. 1 is a 4" x 4" x 4½ ft. wood post or 4" x 5 ft. PVC pipe.  
North Side Center No. 2 is a 4" x 4" x 4½ ft. wood post or 4" x 5 ft. PVC pipe.  
Northeast Corner No. 3 is a 4" x 4" x 4½ ft. wood post or 4" x 5 ft. PVC pipe.  
Southeast Corner No. 4 is a 4" x 4" x 4½ ft. wood post or 4" x 5 ft. PVC pipe.  
South Side Center No. 5 is a 4" x 4" x 4½ ft. wood post or 4" x 5 ft. PVC pipe.  
Southwest Corner No. 6 is a 4" x 4" x 4½ ft. wood post or 4" x 5 ft. PVC pipe.

The monumentation and marking of the corners was completed by the 25  
day of June, 1983. This claim is intended to cover all open ground  
existing within its boundaries as of this date of posting.

The location work consisted of making a claim map as provided in NRS 517.040.  
Two copies of this claim map have been filed with the Eureka County Recorder,  
and the \$20.75 lode claim filing fee has been paid to the County Recorder.
